The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for Garza County Health Care District from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval tax rate is the highest tax rate that Garza County Health Care District may adopt without holding an election to seek voter approval of the rate.
